• We still have not received a check yet from the 2022 or 2023 Soccer Saturday meat raffle/taco feeds from the Cro. I'm assuming we just need to send a letter to request funds? Just not sure on how much to ask for. Anyone have any ideas?

Tournament Registrations:

- Jon has registered some of the teams and has been putting the confirmations in a folder for me on Google. I just haven't had time to assign them to teams yet within our software.
- I'm sure I have emails from coaches/managers that have registered their team and need reimbursements. I just haven't had time to issue them a check yet.

Form 990 Non-profit Organization tax filing:

- Recap again: Both the 11/30/2019 and 11/30/2020 annual tax returns were filed late. The IRS has received these
 late returns and have now sent out late filing fees. The 2019 return was assessed a penalty fee of \$53,000 and
 the 2020 return was assessed \$4,700. I have replied to both of these notices asking for abatement.
- FINALLY received notices that the IRS has abated all of these penalties. What a relief that is!

Rent at Storage Locker:

• Rent has been paid up through April of 2023. Next rent payment is due 5/1/2023 with iStorage.com. Monthly rent will be \$156 plus \$9 insurance.

Mini Soccer stress balls order:
